

THE FRISCO FAMILY

SOUTHWEST PACIFIC RAILROAD COMPANY

The Southwest Pacific Railroad Company was incorporated August 24, 1866, under the provision of an act of the General Assembly of Missouri, approved March 20, 1866. The company was organized by John C. Fremont, to take over the franchise and property of the Southwest Branch of the Pacific Railroad which had been seized by the State of Missouri, and had been purchased from the state by Fremont on June 14, 1866. On January 4, 1867, the company conveyed its franchise and property to the Atlantic and Pacific Railroad Company, which also at that time, was controlled by Fremont and his associates. On June 21, 1867, the property of the company was seized by the State of Missouri, because of the failure of Fremont or the company to pay the first installment on the balance of the purchase price of the Southwest Branch. Such property was retained by the state of Missouri until July 1, 1868, on which date it was conveyed to the South Pacific Railroad Company under the provisions of an act approved March 17, 1868. On June 21, 1867, the date of its seizure by the State, the property of the company consisted of about 89 miles of standard gauge, single track railroad, located in Missouri, extending from Pacific (now Franklin), in a southwesterly direction to Arlington.
